#### *Reservation and Deposit*

*To reserve the banquet room for any event a deposit of \$1000.00 is required. The deposit is due upon receipt of the contract and is non-refundable.*

#### *Minimum Payment Due*

*The first minimum payment of \$3000.00 toward the balance is due ninety days prior to the event.*

#### *Room Rental*

*The Myth Golf and Banquet room rental is \$1000.00. This fee covers the use of standard linens, napkins, skirted tables, china, silverware, and cleaning charges. This fee is due to hold the room for your event and is a separate charge.*

#### *Hours of Operation*

*The banquet room is available for a consecutive six (6) hour period.*

*Set up for decorations are allowed prior to the event. Please contact the wedding coordinator for further details.*

#### *Guaranteed Number of Guests*

If unaware of the details at this time the following will apply: Function details, including the guests attending, room set up, or special considerations are due two weeks prior to the function. #### *Coat Check and Valet Service*

*The Myth Golf and Banquet will provide a coat check service and valet service for a fee of \$200.00 each.*

#### *Music, Entertainment and Other Vendors*

*All service providers, including bands, disc jockeys, florist, bakers, etc may begin to set up three hours prior to the event or there after. Please, no glitter, confetti, or any similar items on the premises. The*

Payment of Account

Full payment is required no later than two weeks prior to the function. Any remaining charges must be paid in full at the completion of the function. All food and beverages are subject to a six (6) percent sales tax and eighteen (18) percent gratuity.

Cancellation

In the event that your function is cancelled for any reason prior to the event, any monies paid will be forfeited due to the expenses incurred and the reservation of banquet facility.

Damage and Loss of Property

The Myth Golf and Banquet does not accept responsibility for damages or loss of items in the building prior, during or after the event. Organizers are financially responsible for any damages sustained to the building, property or equipment by the client, their guests or outside contractors prior to, during or after the event.

Labor Charges
